The photographs of the Farm Security Administration and the Office of War Information in the Prints and Photographs Division of the Library of Congress, fully captioned and arranged by region and by subject. The Farm Security Administration photographic collection is one of the most famous in the world, its images depicting living and working conditions in urban, suburban and rural America during the depths of the Depression and the outbreak of World War II. Yet the collection as a whole is barely known with public awareness based on a handful of photographs reproduced time and again. Publication on microfiche of the 87,000 FSA photographs in the Library of Congress together with a printed Guide/Subject Index makes the collection genuinely accessible allowing researchers to scan through thousands of photographs going immediately to the regions and subjects that interest them.

The Great Exhibition of 1851: Prospectuses of Exhibitors

1851

The Industrial Revolution brought unprecedented change to the Western world. It was an age of accelerated advancement spurred on by a unquenchable thirst for innovation and a new lust for progress. Nowhere was this more evident than at the Great Exhibition of 1851. Conceived and designed as a spectacular display of manufacturing achievements, the Great Exhibition of 1851 was attended by six million people attracted to the 8,200 exhibitors' "modern" wares. Joseph Paxton's enormous Crystal Palace, built from 900,000 square feet of glass to house the exposition, is testimony to the scale of the event's ambition and success. Although mostly supported by British vendors, foreign nations were an integral part of the event. The vast cross-section of products exhibited from the nations of the world was a profound statement of what many believed healthy competition, free trade and general political stability could achieve. More than any previous exposition, this event provided a tremendous opportunity for comparisons of leading products and new innovations and catalyzed subsequent advancements. These technological advancements were detailed in the exhibitors' prospectuses. The Great Exhibition of 1851: Prospectuses of Exhibitors provides insight into the design, technological innovations, business activities and marketing of the time. Comprising nearly 900 individual prospectuses from businesses around the world, the collection is divided into four general categories: raw materials, machinery, manufactures and fine arts. Within these categories, the material has been organized into 30 classes. Prospectuses are included on the following types of products.

Not since the Civil War has a conflict so divided the American public. The Vietnam War is the most political, controversial war ever recorded in American military history. Even today, years after the withdrawal of U.S. troops, researchers strive to separate fact from fiction. All materials have been collected by Douglas Pike, Director of the Indochina Archives at the University of California, Berkeley and a well-known authority on the Vietnam conflict. As a U.S. Foreign Service Officer during the war, he was considered the U.S. Government's leading expert on Vietnamese communism. He has collected materials from not only the United States, but Saigon, Hanoi, Peking, Moscow, Tokyo, Australia and Western Europe. Many documents were gathered from personal contacts during and after Mr. Pike's presence in Vietnam. Organized into the broad subject categories listed below and then arranged chronologically, the collection can be used as a resource for researchers and students and as a unique teaching tool in American and Southeast Asian history, political science, international relations, military history, journalism and many other fields of study. Unit pertaining to Agriculture & Farming:

- **Unit Eight: North Vietnam During the War:** Agriculture/Cambodia consists primarily of press releases and other captured internal documents concerned with agricultural progress in North Vietnam. A smaller section deals with Cambodia from the 1960s to the end of the 1970s.

New England Farmer and Horticultural Journal

1822 - 1846

The New England Farmer was one of the earliest agricultural journals established in the United States and the first and foremost in New England. It is a valuable source of information on the nature of agriculture and society in early 19th century New England, a period of transition from the traditions of home production and processing to the requirements of commercial agriculture. Its coverage of issues such as the changing economy, fashion, temperance and moral reform is of value to social historians in general.

1790 - 1870

Over 500 seed trade catalogues issued by 250 seed companies between 1790 and 1870 providing a graphic insight into the development of the nursery and agricultural business in America in the 19th century. The growth of the seed trade in 19th century America mirrored the increase in population and general prosperity and the nation's westward expansion. Consequently these catalogues will be valuable to researchers working not just on the agricultural and horticultural industries but also on the broader economic and social history of this period. Much of the agricultural and horticultural information in the catalogues is not available elsewhere while many are also minor works of art with fine illustrations of scientific value and varied design and type styles.

Southern Tenant Farmers Union Papers

1934 - 1977

In its zeal to implement New Deal farm programs, the Roosevelt Administration caused the eviction of thousands of southern sharecropper families. Thus incensed, a handful of black and white farmers met in a schoolhouse in Arkansas and formed the Southern Tenant Farmers Union (STFU). This union was to become a powerful force in American labor and would eventually be a prototype for Cesar Chavez's United Farm Workers of America. The Southern Tenant Farmers Union Papers (also called "The Green Rising") encompass a multitude of issues, movements and individual histories on microform. A major acquisition for any library's social science collection, these papers can be used by scholars and researchers investigating the historical perspectives of the New Deal, farm labor, or Southern, Mexican-American and American labor history.

Founded by seven black and 11 white sharecroppers on an Arkansas cotton plantation, the STFU laid the groundwork for and contributed to the creation of the LaFollette Civil Liberties Committee in the U.S. Senate and the Kennedy-Johnson Administration's War on Poverty. The entire history of this influential union can be traced, from its humble beginnings under the auspices of the Socialist Party, through its brief and stormy affiliation with the CIO; from its entry into the AFL up to its merger into another union in the 1960s. A unique feature of this collection is the correspondence from sharecroppers to union officials. Notes scrawled on scraps of paper or penciled on the backs of outdated calendars tell of usurious landlords, sick children and flood conditions.

This supplement to the papers of the STFU features the personal papers and records of four of farm labor's dynamic leaders. H.L. Mitchell Papers - The private papers, subject files and printed materials of STFU co-founder H.L. Mitchell include unpublished and out-of-print studies of Mexican Americans and his correspondence documents STFU's Socialist Party origins. Clyde Johnson Papers - Documented is the life of Clyde Johnson, a dedicated trade unionist who was the last secretary to the Alabama Sharecroppers Union. Featured is an unpublished thesis by Dale Rosen, which documents the facts surrounding the Reeltown Massacre, as well as Johnson's oral history. David S. Burgess Papers - Insight into the lives of migrant workers during the 1940s can be gathered throughout the papers of David Burgess - a minister who saved the homes of 600 families in the Delmo Labor Homes Project of Southeast Missouri. In later years, Burgess was a CIO organizer and head of the Georgia CIO. Thomas H. Gibbons Papers - Gibbons' unpublished "Autobiography of a Technocrat" is based on the author's experiences as a migrant worker and his beliefs in radical economic theory.

Stryker, Roy. Roy Stryker Papers

1912 - 1972

Best known as the man who directed the taking of over 150,000 photographs for the Farm Security Administration during the New Deal era, Roy Stryker is one of the most prominent figures in the development of American documentary photography. His papers reveal the thinking and planning behind his major photographic documentaries making them a unique resource invaluable for research in both the social history of America between the '30s and '50s and the history of photography. The microfilm edition contains 2,000 photographs, nearly three quarters Stryker's personal selection from the Farm Security Administration project including nearly 400 from Russell Lee and 100 each from Walker Evans, Dorothea Lange and Ben Shahn.

At the beginning of the 20th century the United States Department of Agriculture commissioned artists to produce watercolors of new fruit introductions. Over 7,000 paintings covering 38 plant families have survived and are reproduced here on color microfiche. The original paintings are housed in the herbarium of the U.S. National Arboretum. About 40 per cent are designated types while some of the paintings are probably the only illustrations in existence of the cultivars they represent.

Vriese, Dr. W.H. de. The Archive of Professor Dr. W.H. de Vriese: Concerning his Investigation into The Netherlands Indies Cultivations*

1857 - 1862

W. H. de Vriese was a Professor of Botany in Amsterdam and in Leiden in the mid-19th century, specializing in East Indies flora. In 1857 de Vriese was named by the King to undertake a 3-year research project into agriculture in the East Indies, particularly Java. He traveled extensively in the East Indies for two years to write his report, never finally completing it due to his death in 1862. His extensive archives, containing much valuable material, were finally organized, classified and inventoried by Mr. A.M. Tempelaars and comprise this collection.

Sahel: Documents and Dissertations

In recent decades, world attention has been drawn to various areas of Africa affected by natural disasters. The most prevalent have been prolonged droughts and their devastating effects on the people in these precarious, underdeveloped economies. Response to these crises usually involve food airlifts to avert immediate disaster, but there exist few permanent programs designed to avoid drought-related losses. Sahel: Documents and Dissertations documents one cooperative effort in existence among eight independent nations along a 2,600-mile strip of West Africa known as the Sahel. In 1973, the Permanent Interstate Committee for Drought Control in the Sahel (CILSS, after the French initials) was formed by the governments of six countries most affected by a severe drought - Sénégal, Mauritania, Mali, Upper Volta (Burkina Faso), Niger and Chad. The countries of Gambia and Cape Verde joined later in coordinating planning efforts to avoid repeated drought-related disasters. Researchers in African studies, agricultural economics and socio-economics will discover more than 1,000 documents and dissertations that report on the agricultural, economic and socio-economic changes in the Sahel region during and after the drought.

This material - one of the only compilations of its kind in existence - provides fertile ground for studies of the effects of disasters on unstable economies. It also offers a model for an analysis of international cooperative efforts in Africa and elsewhere in the world. Featured are publications from African governments, research funded by USAID (U.S. Agency for International Development), dissertations, theses and reports from the United Nations CILSS, Club du Sahel and other international agencies. Nearly half of the collection is in English, half is in French and two documents are in Portuguese. Besides the technical aspects, the journal also addressed the social problems which were connected with the technical progress: the emergence of factory workers, the formation of trade unions and the first disputes as to environmental pollution. For today's research into the history of technics and industry and their social aspects, the Polytechnisches Journal is a first rate and indispensable source.
