History of Medicine

Albany Medical College Inaugural Theses

1839 - 1891

A primary source for the study of the history of medicine, the Albany Medical College Inaugural Theses contains medical theses from the Albany Medical College, focusing on the disease states, diagnoses, treatments and epidemiological findings of the period. Students of medical sociology, medicine, history of medicine and history of medical education, as well as students of health education, will find facts about the medical social setting - such as "the duties of the physician" and insights on the medical education, medical knowledge and medical practice in Upstate New York for more than half the 19th century. This material applies to most of the medical education of the period without regard to location, geography causing negligible variance in the kinds of medical/ethical issues and diseases challenging American doctors of the 19th century. A glance over the topics reveals trends in diseases that were prevalent and those that caused concern at that time. Thesis subjects include acute bronchitis, cholera, dysentery, erysipelas, gastritis, hepatitis, infanticide, insanity, nutrition, pneumonia, scarlet fever, scrofula (tuberculosis of the lymph nodes), syphilis, typhoid fever, vision defects and yellow fever.

The progress of medical knowledge can be traced with the aid of dissertations written about particular conditions at frequent intervals. For example, students in epidemiological history can examine theses that appear nearly every two years from 1859 to 1890 on the subject of diphtheria (for a total of 57 theses). An even larger number of theses are included on the subject of typhoid fever - for a total of 92 theses from 1853 to 1891. Other dissertations focus on practices later condemned, such as "bloodletting" and "leaching." Some cover mental illness (specifically insanity), the mind and imagination - works from the early beginnings of the profession of psychiatry as we know it today. In addition, researchers will note trends in obstetrics and gynecology, as well as attitudes toward women's "afflictions" and "hysteria." The medical historian will find many theses on the medical profession itself and the progress of medicine, including attention to questions about the proper role and etiquette of the physician: what kind of care the doctor is duty-bound to provide and what the doctor's duty is to society. The theses were filmed from archives of the Albany Medical Center in Albany, New York and compiled by Rue Moore, Canon of the Archives at the Medical Center. Due to its thoroughness and bibliographic integrity, as well as the historical significance of the diseases, topics and trends covered, the collection is of vital interest to medical historians and students

The Tacklehouse and Ticket Porters and the Comb-Makers minute books, accounts and other records, 1566-1895, is a collection shedding particular light on The Fellowship Porters, an organization with roots in the 13th century that retained sole rights to the handling of measurable commodities until the mid-19th century. Like most of the City Livery Companies, the origins of the Pewterers Company lie in the Middle Ages. During the 15th century, craftsmen began to exercise more control over their own trades. The Crown granted charters allowing craftsmen to form guilds that exercised extensive jurisdiction over all aspects of the trade. The Pewterers were granted a charter by Edward IV in 1474 and their records, extant from 1451, continue unbroken, embracing later charters, company ordinances, by-laws and records of members.

The aging of our populations has compelled scientists and society at large to focus major new efforts in the varied disciplines of gerontology and geriatric medicine. The Microfiche Library of Gerontology and Geriatrics offers training materials covering all aspects of aging, answering the need for a definitive source of information in the geriatric and gerontological fields of study. These key materials have previously been available only in scattered libraries and in diverse, sometimes inconvenient formats. The collection covers the psychological, behavioral and social and health care aspects of aging. Included are authoritative selections of original contributions based on bibliographies, course outlines and curriculum guides, as well as medical training guides. In addition, manuals, pamphlets and flyers from training programs around the world have been included.

Materials for this collection have been compiled and indexed by subject from Duke University's "Key Word Indexed Collection of Training Resources in Aging Project" so that users may benefit from work that has been done in curriculum and program development. There are materials for B.S./B.A., continuing education and graduate programs. Specific training materials focus on topics including long-term care, nutrition, programs for older adults, program administration, pre-retirement programs and volunteer programs. Within the Aging General section, manuals touch on issues such as: definition of old age, social policy and social ethics, the aging society, psychological changes, life-span, senility and how to respond to it, aging among minorities including Native Americans and other cultures, and sexual life among the aging, love and widowhood. Worthy of special note is an oral history entitled, "Old is What You Get; Dialogues on Aging by the Old and the Young," written by A.Z. Shanks. Educators and professionals will also find the Design/Evaluation materials valuable. Titles include:

This microfiche collection provides scholars, students and historians with a fine collection of primary sources for comprehensive study of the history of pharmacy as a science and a profession in the United States. It traces the practice of pharmacy from the Colonial Period, when European methods met Native American naturalist treatments, through the development of modern pharmaceutical practice based on biomedical research. The collection contains books on

- pharmaceutical law
- treatises
- lectures
- textbooks
- antiquarian and scholarly materials

There are drug catalogs and formula books that provide vivid descriptions of medicines and instructions on how to use them. Botany texts document the medicinal use of various plants in the treatment of illness. Any institution supporting a degree-granting pharmacy program as well as allied health science programs such as nursing or medicine will find this collection to be a necessary resource for teaching and research. The collection was filmed at the University of Wisconsin in cooperation with the American Institute of the History of Pharmacy. Some books are from the National Library of Medicine at Bethesda, Maryland and the Center for Research Libraries, Chicago, Illinois.

1950 - 1989

Only in recent decades has the U.S. become committed to developing the full potential of physically and mentally disabled citizens. New programs have arisen out of this commitment - from "mainstreaming" in public schools to barrier-free building design. And along with this shift in focus, there has been a tremendous quantity of literature produced on the subject of rehabilitation. This valuable, informational literature has originated from scattered sources. Much of it, such as many excellent handbooks for the disabled, was never released commercially in printed form. Now these vital resources are available, drawn together in one easy-to-use microform collection, Rehabilitation and Handicapped Literature. Professionals such as physicians, physical therapists, nurses, social workers and others working with the handicapped or involved in rehabilitation programs and facilities find this collection to be a definitive reference source on physical and mental disabilities, therapies and new rehabilitation programs.

The base collection consists of approximately 1,500 full-text items assembled by The National Rehabilitation Information Center (NARIC). NARIC is the national research library serving as both abstractor and indexer for all research reports and audiovisual materials sponsored by the National Institute of Handicapped Research. Featured are statistical surveys, case histories and handbooks for the disabled. In addition to the base collection, updates are now available through 1989. Any institution supporting academic and research programs in rehabilitation, physical medicine, occupational therapy, special education, mental health, rehabilitation engineering and more will find this collection unequalled in bringing together disparate resources for their use. The material spans every aspect of physical and mental rehabilitation, including:

- **Physical Disabilities/Behavioral Disorders:** paraplegia, quadriplegia, amputation, mental illness, mental retardation, spinal cord injury, hearing and visual impairment and more
- **Rehabilitation Professionals and Techniques:** administration, behavior modification, counseling, evaluation, occupational therapy, research utilization, speech therapy and others

The Royal Hospital of St. Bartholomew: Minute Books, Accounts and Other Records*

1547 - 1801

St. Bartholomew's Hospital is now at the very centre of the controversy over National Health Service reforms, but it is one of the oldest and most distinguished hospitals in the English speaking world. The microfilmed records offer a unique source of detailed information on the hospital since its re-foundation under Henry VIII. The 16th, 17th and 18th centuries were a critical period in the development of British medicine and St. Bartholomew's was one of the very few hospitals functioning through this period. The records cover finance and administration, staff policy, patient care, as well as its relations with benefactors, tenants and the medical world in general.

Royal Maternity Charity Minutes: Unique Insight into Obstetrics and Midwifery Practices

1761 - 1949

The Royal Maternity Charity was instituted in 1757, its purpose the care of the pregnant poor of London. The Charity soon won royal patronage and continued to flourish until 1949, when it was replaced by the National Health Service. This microfilm collection provides a unique insight into obstetrics and midwifery practice during the 18th and 19th centuries. Many of the leading obstetricians of the day were physicians to the Charity, including those associated with the death in childbirth of Princess Charlotte. The 30 volumes of case records here include detailed treatments of labor complications such as forceps extraction and breach delivery. The collection also contains the Robert Barnes Casebook, 1857-1868. Barnes was one of the most celebrated obstetricians of his day and physician to the Charity for 12 years. This unique volume, now in the library of the Royal College of Obstetricians and Gynecologists, contains notes on 370 of the cases he attended. Most of the notes are detailed, often accompanied by sketches of the conditions observed.

St. George's Hospital, Hyde Park Corner: Minutes of the Board of Governors*

1733 - 1888

The Minute Book of St. George's Hospital Board of Governor's records that the hospital admitted its first patients to the Hyde Park Corner site on 1st January, 1734. Sixty-four patients were treated in the first month and the Minute Book also details the complaints as including: "dropsy, albugo, scorbutic eruptions, flux, contusion", etc... The microfilm of the St. George's archive offers a conveniently-formatted opportunity to follow the records of a major hospital from it's inauguration as an independent institution reliant on the generosity of benefactors right through a century and a half of its development into a leading London medical centre. The prevalence and occurrence of diseases throughout the 18th and 19th centuries as well as the progress against them can be monitored. In addition the microfilm makes available for study the lives, conditions and salaries of the staff, together with the day-to-day administration of a hospital in the years before the National Health Service.

Trinity College Cambridge Library: Mediaeval Manuscript Collection*

The world famous library of Trinity College, Cambridge is the home of some of the greatest treasures surviving from the Middle Ages. The collection, which contains some 1,500 volumes, has been microfilmed in its entirety and will allow scholars the opportunity to explore a unique source of information on every aspect of mediaeval knowledge. Though manuscripts such as The Trinity Apocalypse, the Canterbury Psalter, the Winchester Psalter and a copy of St. Paul's Epistles (possibly in Bede's own hand) stand out, it is the depth and range of Trinity's holdings which make this collection such an indispensable source.

Featured in the Archives are the letters, diaries, family papers and photographs of Adelaide Nutting and other leaders in nursing education, including Lavinia Dock, Isabel Stewart and R. Louise McManus. Studies performed by the Columbia University Department of Nursing Education and by national organizations, government reports on health and nursing (particularly during the World Wars) and a biographical file of prominent nursing pioneers are included. This part of the collection contains 85,000 items, dating from 1899 to the present.

The Supplement to Part II, released in 1986, adds another body of important material to this collection. It contains the personal and professional papers of two of nursing's outstanding 20th century leaders: Eleanor C. Lambertsen and Eugenia K. Spalding. Eleanor Lambertsen was active in many facets of nursing, including the National League for Nursing and the American Hospital Association. Included in this section are records from her many government positions with the Department of Health, Education and Welfare, the Veteran's Administration and the Department of Defense, plus her work for New York State and many prestigious health foundations. The papers of Eugenia K. Spalding document her major role in the education of nursing faculty and the appraisal and improvement of nursing education programs. Among the materials included are papers pertaining to her work in the United States Public Health Service, her tenure at Teachers College, Columbia University, as well as her lectures, addresses and published works.

**Archive of European Lexicography: Specialized Encyclopedias:
History of Medicine***

1550 - 1950

Occidental medicine has gone through immense changes within the last centuries. Its history is marked by a multiplication and a splitting-up of empiric knowledge as well as competing theories existing side by side and one after the other. Thus it became necessary to form an idea of both knowledge and theories. This process, which was characterized by a philologically and philosophically oriented discipline in which the etymological deduction and terminological definition played an important role, turned out to become a highly differentiated experimental science. In its entirety it nowadays has the capacity of voluminous encyclopedias. The medical dictionaries and encyclopedias presented here provide a true piece of a period of more than three centuries: from mid-16th century up to the early 20th century. They provide the reader with more information on the respective state of contemporary medicine, on it's concepts, it's models and its focuses of knowledge. This edition has made works available the access to which had so far been difficult. It provides an indispensable and valuable help for everyone interested in the history of medicine.

The Medieval Manuscripts from the Anhalt Regional Library Dessau *

The Anhalt regional Library can look back at an eventful history: opened back in February 1922 as Anhaltische Landesbucherei, it's holdings based on the Ducal Administrative Library founded between 1876 and 1878. During the 1920's, several additional collections found their way into the Anhalt Regional Library, part of which were the Ducal Court Library and Georg's Library. During world War II the library was struck hard by a major damage: about 90 percent of its holdings were lost. Thanks to intensive exchange deals after 1945 - for example with the Berlin, the Gotha and the Halle Libraries - the library's inventory increased again. In 1959, the library was integrated to the Halle University and Regional Library. A few year later it was united with the Dessau City Library and eventually, in 1991, the library received it's original name: Anhaltische Landesbucherei. Today its collection numbers 111,000 volumes, 10,000 of which are old holdings. The collection contains texts in Latin, German, Hebrew, Italian and French. The thematic spectrum reaches from theology, law, art, poetry, music and medicine to the natural sciences. Among today's manuscript holdings from the Anhalt Regional Library, the Georg's Library is the largest. The most valuable manuscripts mainly belong to this library.

This collection reached its peak back in the early 18th century: in 1715 it numbered 2,335 titles. Also integrated into the Herzogliche Behördenbibliothek were: the Arnstadt and Sonderhausen Library; the library of the convent Gerode, the library of the Fürstlich Anhaltische Deutsche Gessellschafft (Anhalt's Princely German Association), the collections from the Mining Department Harzgerode, the Medicinal Libraries Bernburg and the Anhalt Collection owned by the pastor and historian Theodor Elze (1823-1900).
