



Regulatory Histories associated with Public Laws include:

- Federal Register articles organized by RIN (if available), with links to associated contemporaneous CFR Parts
- Links to current CFR Parts associated with the Public Law
- Public Law text and bibliographic information
- Additional controlled vocabulary subject indexing harmonized with Legislative Insight
- Links to Comments Archive

Regulatory Histories associated with Executive Orders include:

- Federal Register articles
- Links to histories of related Executive Orders

Agency View compilations include:

- Final rules promulgated by the agency.
- Links to recent proposed and final rules
- Links to rules of predecessor and successor agencies and agencies with related jurisdiction over CFR Parts. These links address problems caused by government reorganization, which can make it difficult to trace the history of a regulation from the department/agency perspective.

Comments Archive includes:

- Find terms look-up for commenting agencies and organizations
- Ability to limit results to comments with attachments
- Ability to limit results to comment period open or closed
